

Additional (third) vaccination

Steps to get vaccinated



1 Receive a notification and a ticket.

Those who can receive an additional (third) vaccination of COVID-19 are those who have been vaccinated for more than 6months since the date of completion of the second vaccination. A notification and a ticket are sent to you by the municipality where your address is registered on your residence card.

XIf you move to another city, please contact the vaccination call center where you move.

2 Make an appointment to get vaccinated.

2 If you want to get vaccinated at metropolitan large-scale vaccination site,

⇒ Please check Tokyo Metropolitan website and make an appointment.

What to bring on the vaccine day

- ·Set of the envelope containing this notice
- ·ID(such as MY NUMBER CARD, driver's license card and health insurance card)
- *Additional vaccination is once.
- XEach venue may have its own type of vaccination. Please make sure to check it.
- *On the vaccination day, make sure to bring your ID, the sent certificate written your first and second vaccination records, and questionnaire (two pages, second page is a copy of the first page.)

(Make sure to fill out the questionnaire beforehand.)

- *Before you leave, check your body temperature. If you have a fever or feel sick, refrain from vaccination and call the call center for cancellation.
- **Please come over with the clothes that make it easy to access your shoulder.

Those who are especially recommended additional vaccination

- "Those who have higher risks to become severe" such as the elderly and those who have underlying conditions.
- "Those who have close contacts with those who have higher risks to become severe" such as people involved with those, caregivers and nursing care staff.
- "Those who have higher risks to be exposed with the virus for medical professional reasons" such as medical workers

When you get vaccinated at the place where you are not registered as a resident

- Those who are staying at medical or another facilities and get vaccinated there ⇒ Please check the staff where you are staying at.
- Those who have underlying conditions, take treatment at the hospital and get vaccinated there → Please ask the doctor.
- Those who live in a different address from a registered address → You may get vaccinated in the region where you actually live. Please check the website you live in or refer to the call center.

○When you get vaccinated, your self-consent is needed.

Before you get vaccinated, you need to understand both positive effects to avoid infections and risks for side-effects correctly and please make sure to decide it on your own will. Without recipient's consent, vaccination will not be conducted.

DO NOT force the people at your working place or around you to get vaccinated nor discriminate with those who have not gotten vaccinated.

© Relief System for injury to Health with Vaccination is available.

Vaccination may cause damage to human health (such as getting sick or remaining disabled). Although it shall hardly happen, it cannot be eliminated so this system is in place. Please refer to the municipality where your address is registered on your residence card when you want to know required procedures to apply for it.

After vaccinated, your cooperation to follow measures to avoid spreads such as mask. mandate will be demanded.

COVID-19 vaccine is verified its high effectiveness to prevent the onset of COVID-19 but it is not 100%. It is also affected by variant. That is why you all are demanded to keep following measures to prevent from spreads. Concretely speaking, Avoid 3C(Crowded, Close contact and Closed space), Mask mandate, Wash your hands with soap and Sanitize hands and fingers by disinfectant.
